

Governor Meets with Aging Advocates

Advocacy representatives from Area Agency on Aging 1-B participated in a discussion roundtable with Governor Jennifer Granholm and administration officials Ishmael Ahmed, director of Michigan Department of Human Services, and Sharon Gire, director of Michigan Office of Services to the Aging (OSA) to discuss ways to improve advocacy when communicating with legislators in Lansing. The event was sponsored by the *Regional Senior Collaborative*, a coalition of 25 Detroit area non-profits engaged in providing services and resources to older adults. The officials praised the aging network's work with vulnerable older adults and individuals with disabilities, and emphasized that advocacy is effective at the state level, despite program cuts over the years. Director Gire pointed to the MI Choice Medicaid Waiver program as having been borne of advocacy.

Governor Offers Advocacy Advice

The Governor offered the following advice to improve effectiveness of advocacy efforts:

- Encourage participation by older adults at rallies and local events attended by legislators.
- Invite lawmakers to come to our communities and organizations to meet individuals and families who depend on state supported services.
- This election season provides an opportunity to get commitments from candidates to support OSA and the Medicaid "optional" programs such as MI Choice and Home Help.

Other advocacy suggestions from participants included demonstrating to legislators how the *Regional Senior Collaborative* member organizations work together to support aging services, and trumpeting the person-centered approaches to delivery of services.

Revenue Enhancements

Should They Be Used to Close the Budget Gap?

Governor Jennifer Granholm's FY 2011 budget proposal includes an 8% cut in funding for the Office of Services to the Aging, which provides monies for nutrition, volunteer, and in-home services. This funding cut is based on proposed new revenues such as a sales tax on services and a physicians tax, and is likely to grow if new revenues are not approved. The AAA 1-B would like to know whether advocates support the generation of new revenue (such as taxes) to support state services, in addition to the proposed cuts and government reforms.

Tax on physician services of 3%	\$300 million in state funds; \$822 million in federal funds
Sales tax decrease from 6% to 5.5%, and applied to certain services as well as consumer goods	\$1.65 billion for the state's School Aid fund, relieving the general fund from subsidizing schools
Replace flat rate state income tax with graduated rate tax	\$600 million
Double Michigan's Beer Tax to 4 cents per 12 oz. beer	\$42 million
Offer specialty license plate for sale	Comparable programs have raised from \$46,000 to \$447,000
Add a check-off donation box to the state income tax form	Comparable programs in other states have raised from \$11,000 to \$250,000

2010 Legislative Advocacy Platform

Protect vulnerable seniors: Fund senior and long term care programs

No further cuts to Office of Services to the Aging programs like home delivered meals, in-home care, senior volunteers, and caregiver respite.

- Approve Governor's recommended \$14 million increase in the MI Choice home-based nursing home alternative.
- No further cuts to Medicaid health, mental health and nursing home providers.

Protect vulnerable seniors: pass Elder Abuse laws

- The 2006 Governor's Elder Abuse Task Force Report calls for the adoption of several laws that would enhance protection for vulnerable older adults. Not one piece of legislation implementing the recommendations has been passed by the legislature.
- More than 20 elder abuse bills are before the legislature, and 8 bills have passed the House and are awaiting action in the Senate. These bills must pass.
- Protections needed by older adults include: require reporting by financial institutions of suspected abuse; increase penalties for abuse or exploitation; require court appointed guardians to be bonded; allow videotaped testimony; and allow courts to freeze assets when necessary to protect seniors' savings.

Invest in prevention programs that work

- Support Older Michiganians Act programs that prevent, delay, or divert dependence on costly Medicaid and institutional care.
- Expand financing for evidence-based wellness programs, offered by senior centers and other aging network organizations, that lower health care costs.

Make Michigan a retirement destination of choice

- Support legislation that creates communities that embrace an aging and disabled population. Seniors are a \$32 billion economic force in Michigan. Their economic contributions create jobs that will not leave the state. Their income is imported into the state's economy (Social Security, pension, earnings on investments).

Reform Michigan government and taxation to match current conditions and needs

- Restructure Michigan's tax system with fairness to promote economic growth; reform government operations to maximize cost effectiveness; and raise needed revenues for state-supported services by closing tax loopholes.
